



IRCCA Registration Form (Purchasers)

The Indian River Club Community Association's (IRCCA) restrictive Covenants and Documents govern the use and occupancy of properties in this Community and are intended to protect the beauty of our Community and also requires approvals from the Architectural Committee prior to commencing any type of outside work. The current property owner is responsible for providing the IRCCA documents to you for your review (including but not limited to the Articles of Incorporation, Amended and Re-stated Declaration of Protective Covenants, Amended and Re-stated Bylaws and Compliance and Design Standards).

Prior to your move into our Community, the IRCCA Orientation Committee will contact you to schedule an informal and informative meeting where they can answer any questions you may have about the Community and also provide to you a Resident Guidebook.

All individuals owning, purchasing or leasing property at the IRC Community are required to register with the IRCCA by completing the IRCCA Registration Form. The IRCCA Registration requires review by the IRCCA Board of Directors.

The registration process will not begin until all the required items are received.

When submitting an IRCCA Registration to purchase, please include the following:

1. Completed IRCCA Registration Form
2. \$25 nonrefundable processing fee payable to Elliott Merrill Community Management
3. \$100 nonrefundable registration fee payable to IRCCA
4. Copy of the signed sales contract

The IRCCA Registration Form along with the required items must be received by Elliott Merrill Management Company at least seven (7) days prior to the proposed closing date (Saturdays, Sundays and Holidays excluded). Please forward all the required items to:

Ten days after closing, kindly forward a copy of your Warranty Deed to Elliott Merrill Community Management.

Summary of Lot Transfer Requirements

- Florida Statutes require the current owner to provide to the purchaser several documents including but not limited to the IRCCA Governing Documents.
- The IRCCA Covenants obligate all property owners to be members of the Indian River Club Community Association.
- Mandatory contribution to Conservation Reserve Account of \$2,500.
- Application for membership in the New Indian River Club (Golf Club) is required. (Club's number 772-770-0757)
- The statements contained in this disclosure are only intended to be a summary.

In Advance Of Your Move

- Prior to your move into or out of the IRC Community, **it is your responsibility** to contact both Mike Thornton, Chair of the Access Control Committee and the attendant at the Main Gatehouse advising them of the date and time of your planned move.

- The Main Gatehouse telephone number is 772-563-2935.
- Mike will assign an IRC Moving Coordinator to provide assistance and instructions to you and the moving company as you move in or out of the Community.
- Please note, all moving companies must be bonded and insured.
- Without such notification, access may be denied.

When Planning Your Move, Note The Moving Activity Days And Times

- Weekdays - 7:30 am to 5:00 pm
- Saturdays - 7:30 am to 5:00 pm

The Indian River Club has posted the above Moving Days and Times for the quiet enjoyment of the Community and neighborhoods. Please keep this in mind when scheduling your move.

Kindly do not schedule your move on the following Holidays: New Year's Day, Memorial Day, Independence Day, Labor Day, Thanksgiving, and Christmas. Your neighbors would appreciate it.

Exceptions must be approved by the Board of Directors prior to the moving date.

Additional Information To Be Discussed With Your IRC Moving Coordinator

- There are two primary entrances/exits to the IRC Community through which oversized vehicles are never permitted.
- All "oversized" vehicles and trailers (including but not limited to 18-wheelers) determined by the rule of common sense, shall enter the Community using the Service Entrances only.
- Due to the configuration of the IRC Community infrastructure and streets, the height, width and length limitations prevent "oversized" vehicles and trailers direct access to several streets and driveways within the Community. In some cases, offloading of "oversized" vehicles is required.
- Damages to entrance gates, signs, irrigation, landscaping, etc., caused by a moving vehicle must be reported to Elliott Merrill Community Management, 772-569-9853. Elliott Merrill will assess the damage, determine the costs of repairs and make arrangements for all repairs. The moving company, contractor or property owner will be charged for repairing damaged property.
