Operating Agreement of INDIAN RIVER GOLF, LLC a Florida Limited Liability Company

This Operating Agreement (the "Agreement") is created this 20 day of November, 2008, by INDIAN RIVER CLUB COMMUNITY ASSOCIATION, INC. (the "Member").

Explanatory Statement

The Member has organized and operated a limited liability company in accordance with the terms of, and subject to the conditions set forth in the articles of organization and this Agreement.

SECTION I Defined Terms

The following capitalized terms shall have the meanings specified in this Section I. Other terms are defined in the test of this Agreement; and, throughout this Agreement, those terms shall have the meanings respectively ascribed to them.

"Act" means the Florida Limited Liability Company Act, as amended from time to time.

"Agreement" means this Agreement, as amended from time to time.

"Code" means the Internal Revenue Code of 1986, as amended, or any corresponding provision of any succeeding law.

"Company" means the limited liability company organized in accordance with this Agreement.

"Interest" means a Person's share of the Profits and Losses of, and the right to receive distributions from, the Company.

"Interest Holder" means any Person who holds an interest, whether as a member or as an unadmitted assignee of Member.

"Involuntary Withdrawal" means, the occurrence of any of the following events:

- (i) The Member makes an assignment for the benefit of creditors;
- (ii) The Member files a voluntary petition of bankruptcy:
- (iii) The Member is adjudged bankrupt or insolvent or there is entered against the Member an order for relief in any bankruptcy or insolvency proceeding.

"Member" means the Person signing this Agreement and any Person who subsequently is admitted as a member of the Company.

"Membership Rights" means all of the rights of a Member in the Company, including a Member's: (i) interest; (ii) right to inspect the Company's books and records; (iii) right to participate in the management of and vote on matters coming before the Company; and (iv) unless this Agreement or the Articles of Organization provide to the contrary, right to act as an agent of the Company.

"Person" means and includes an individual, corporation, partnership, association, limited liability company, trust, estate or other entity.

"Positive Capital Account" means a Capital Account with a balance greater than zero.

"Profit" and "Loss" means, for each taxable year of the Company (or other period for which Profit or Loss must be computed) the Company's taxable income or loss determined in accordance with the code.

"Treasury Regulations" means the income tax regulations, including any temporary regulations, from time to time promulgated under the Code.

"Department of State" means the Florida Department of State.

"Successor" means all Persons whom all or any part of an Interest is transferred either because of (i) the sale or gift by Member of all or any part of his interest, (ii) an assignment of Member's Interest due to member's involuntary Withdrawal, or (iii) because Member dies and the Persons are Member's personal representatives, heirs, or legatees.

"Transfer" means, when used as a noun, any voluntary sale, hypothecation, pledge, assignment, attachment, or other transfer, and, when used as a verb, means voluntarily to sell, hypothecate, pledge, assign, or otherwise transfer.

"Withdrawal" means a Member's dissociation from the Company by any means.

SECTION II Formation and Name; Office; Purpose; Term

- 2.1 Organization. The Member hereby organizes a limited liability company pursuant to the Act and the provisions of this Agreement and, for that purpose, have caused Articles of Organization to be prepared, executed and filed with the Department of State on June 3, 2008.
 - 2.2 Name of the Company. The name of the Company shall be "INRIGO".
 - 2.3 Purpose.
- 2.3.1 INRIGO is organized to own and hold title to the Indian River Golf Club property and assets. INRIGO is also authorized to enter into a ten (10) year leaseback purchase of the golf club property with The Indian River Club, Ltd. To the extent permitted by applicable law, it is the intention of the parties that the lease contract be treated as a financing regiment for the purpose of state, federal, local and bankruptcy purposes as to the payments due as Base Rent.
- 2.3.2 INRIGO is authorized to borrow from Member and/or commercial lenders, funds sufficient for the purchase of the Indian River Golf Club on such terms and conditions of sale and purchase as set out in the Agreement dated September 25, 2008, between INRIGO and The Indian River Club, Ltd.
- 2.3.3 INRIGO is also authorized to enter into loan agreements with The Indian River Club, Ltd. for the purpose of financing short term operating cash flow deficits during the term of the lease.
- 2.4 Term. The term of INRIGO began upon the acceptance of the Articles of Organization by the Department of State and its duration shall be perpetual, unless its existence is sooner terminated pursuant to Section VII of this Agreement.
- 2.5 Principal Office. The principal office of INRIGO shall be located at c/o Keystone Property Management Group, Inc., 2001 9th Avenue, Suite #308, Vero Beach, Florida 32960-3365.
- 2.6 Registered Agent/Registered Office. The name and street address of INRIGO's registered agent and registered office in the State of Florida shall be Jane L. Cornett, Esq., 401 East Osceola Street, Stuart, Florida 34994.

2.7 Member. The name, present mailing address, and membership interest of the sole Member is set forth on Exhibit "A".

SECTION III Capital; Capital Accounts

- 3.1 Initial Capital Contributions. Upon the execution of this Agreement, Member shall contribute to INRIGO the cash and property set forth on Exhibit "A".
- 3.2 No Other Capital Contributions Required. Member shall not be required to contribute any additional capital to INRIGO, and except as set forth in the Act, Member shall have no personal liability for any obligations of INRIGO.
- 3.3 Loans. Member may, at any time, make or cause a loan to be made to INRIGO in any amount and on those terms upon which INRIGO and the Member agree.
 - 3.4 Capital Accounts. A capital account shall be maintained by INRIGO for the Member.

SECTION IV Profit, Loss, and Distributions

- 4.1 Distributions of Cash Flow. Cash Flow for each taxable year of INRIGO shall be distributed to Member no later than seventy-five (75) days after the end of the taxable year.
 - 4.2 Allocation of Profit or Loss. All Profit or Loss shall be allocated to Member.
- 4.3 Liquidation and Dissolution. If INRIGO is liquidated, the assets of INRIGO shall be distributed to Member or to a Successor or Successors.

SECTION V Management: Rights, Powers, and Duties

- 5.1 Management. INRIGO shall be managed in the following fashion:
- 5.1.1 Member, through its Board of Directors, will appoint an Advisory Board with up to a maximum of seven (7) members. The Advisory Board will include a representative of the Board of Directors of the Member who will serve as chairman of the Advisory Board as well as liaison between the Advisory Board and Member. The Advisory Board shall also include representation from the golf membership of The Indian River Club. The Advisory Board shall be responsible for recommendations to Member as to operations, including development of a long range plan for INRIGO property. The Advisory Board shall make quarterly reports to the Member and may be made more frequently at the discretion of the Advisory Board.
 - 5.1.2 Final management decisions for INRIGO shall be made by Member.
- 5.2 Personal Services. Member shall not be required to perform services for INRIGO solely by virtue of being the Member.
 - 5.3 Liability and Indemnification.
- 5.3.1 Member shall not be liable, responsible, or accountable, in damages or otherwise, to INRIGO for any act performed by it with respect to INRIGO matters, except for fraud.
- 5.3.2. INRIGO shall indemnify Member for any act performed by it with respect to INRIGO matters.

SECTION VI Transfer of Interests and Withdrawal of Member

6.1 Transfers.

- 6.1.1. Transfers by Member. Member may Transfer all, or any portion of, his interest or rights in, his Membership Rights to one or more Successors.
- 6.1.2. Transfer to a Successor. In the event of any Transfer of all or any part of Member's Interest to a Successor, the Successor shall thereupon become a Member and INRIGO shall be continued.

SECTION VII Dissolution, Liquidation, and Termination of the Company

- 7.1 Events of Dissolution. INRIGO shall be dissolved upon the happening of any of the following events:
 - 7.1.1. if the Member determines to dissolve INRIGO.
- 7.2 Procedure for Winding Up and Dissolution. If INRIGO is dissolved, the affairs of INRIGO shall be wound up. On winding up INRIGO, the assets of INRIGO shall be distributed, first, to creditors of INRIGO in satisfaction of the liabilities of INRIGO, and then to the Member.
- 7.3 Filing Articles of Dissolution. If INRIGO is dissolved, Articles of Dissolution shall be promptly filed with the Department of State. If there are no remaining Members, the Articles of Dissolution shall be filed by the last Person to be a Member; if there are no remaining Members, nor a Person who last was a Member, the Articles shall be filed by the legal or personal representatives of the Person who last was a Member.

SECTION VIII Books, Records, Accounting, and Tax Elections

- 8.1 Bank Accounts. All funds of INRIGO shall be deposited in a bank account or accounts opened in INRIGO's name. The Member shall determine the institution or institutions at which the accounts will be opened and maintained, the types of accounts, and the Persons who will have authority with respect to the accounts and the funds therein.
- 8.2 Books and Records. The Member shall not be required to keep or cause to be kept complete and accurate books of INRIGO nor supporting documentation of the transactions with respect to the conduct of INRIGO's business. The books and records, if any, shall be maintained in accordance with sound accounting principals and practices.
- 8.3 Annual Accounting Period. The annual accounting period of INRIGO shall be its taxable year. INRIGO's taxable year shall be selected by the Member, subject to the requirements and limitations of the Code.

SECTION IX General Provisions

- 9.1 Applicable Law. All questions concerning the construction, validity, and interpretation of this Agreement shall be governed by the internal law, not the law of conflicts, of the State of Florida.
- 9.2. Section Titles. The headings herein are inserted as a matter of convenience only, and do not define, limit, or describe the scope of this Operating Agreement or the intent of the provisions hereof.

- 9.3 Terms. Common nouns and pronouns shall be deemed to refer to the masculine, feminine, neuter, singular and plural, as the identity of the Person may in the contest require.
- 9.4. Separability of Provisions. Each provision of this Agreement shall be considered separable; and if, for any reason, any provision or provisions herein are determined to be invalid or contrary to any existing or future law, such invalidity shall not impair the operation of or affect those portions of this Operating Agreement which are valid.
